## **Qualification Outcomes**

This qualification reflects the role of senior managers and small business owners of personal services businesses. They are responsible for coordinating the day-to-day operation of the business and for planning, monitoring and evaluating the work of the team. Salon managers also operate with significant autonomy to make strategic business management decisions.

This qualification provides a pathway to work as a salon manager in any type of personal service business including remedial massage clinics, skin clinics, retail management or beauty salons & spas.

## **Study Options**

This full time course runs for 52 weeks and includes a combination of face to face classroom instruction and practical experience.

Training and assessment are delivered by Demi International Beauty Academy (RTO #32542) under a Third-Party Partnership Agreement.
